Governor DeSantis,

In light of your August 28 Emergency Declaration¹ and the serious threat posed by Hurricane Dorian, we write to ask that you enact and widely publicize policies to protect public safety as Florida prepares for Hurricane Dorian. Specifically, we request that you amend your declaration and immediately issue a public statement suspending immigration enforcement by state and local authorities pursuant to Chapter 908 of Florida Statutes in all areas under a state of emergency, and in areas where residents are evacuating, sheltering, passing through and later evacuees will be returning to their homes. ICE has already announced suspension of immigration enforcement activities as of August 29.² Consistent State and local action on this is needed to ensure an orderly and effective preparation for and response to the storm, and to allow law enforcement to focus on protecting the safety of the public.

Access to shelter during a natural disaster is a fundamental human right, and preparation and evacuation should never lead to detention or deportation. Fear in immigrant communities is at an all-time high and, without intervention, will prevent families from accessing vital services, including taking shelter in public facilities, when needed, and protecting and assisting others. Florida's recently passed SB 168 exacerbates this sentiment. In this environment, immigrant residents and their families may not take lifesaving steps to evacuate, go to shelters, and access emergency aid efforts unless Florida makes specific public reassurances that immigration enforcement is suspended. Such assurances are critical to the ongoing safety of all residents during this humanitarian crisis and necessary so that resources can be focused on life-saving activities, preventing the loss of property to the extent possible, and assisting with a speedy recovery of the affected region.

ICE has suspended immigration enforcement as it has done during storms over the past several years, including during Hurricanes Irma³ and Michael.⁴ However, in the past, SB 168 was not law. All directives in these moments should be clear and unequivocal⁵ that all state and local cooperation with ICE enforcement in a humanitarian disaster relief area is suspended during the state of emergency and while preparation and relief efforts of evacuations, sheltering, and return of evacuees to their homes is on-going.
